ELECTRICAL CONTRACTOR REGISTRATION REQUIREMENT

1. **ONLY** the supervising electrician may apply for registration **in person**, at the Downtown Office.
2. Contractor must be licensed from a city, town or village that has a commission with an examination in the State of Illinois, submitting a copy of the license.
 - (a) **WRITTEN VERIFICATION OF TEST MUST BE PROVIDED ONLY IF THE LICENSE DOES NOT STATE THAT AN EXAMIN WAS GIVEN AND PASSED.**
3. A certificate of General Liability is required in the amount of \$1,000,000.00 naming Cook County Department of Building and Zoning including the department address as the certificate holder.
4. If the company is a corporation, submit a copy of the corporation papers verifying the company is a corporation with a list of the corporate officer, on letterhead with the corporate seal or the FEIN number.
5. Child Support Compliance Data Form must be filled out by the **supervising electrician only.**
6. Registration fee is \$105.00 paid upon registering, paid by cash, check or money order only. Checks or Money Orders payable to **Cook County Collector**

THERE IS AN ANNUAL FEE OF \$52.50 DUE DECEMBER 1; THIS IS REQUIRED TO MAINTAIN YOUR REGISTRATION WITH OUR DEPARTMENT.
